2. Pending the outcome of the Police Sergeant Appeals Hearing; notice and appropriate action regarding the approval of the eligibility list for the position of Police Sergeant created from Police Sergeant Examination administered on August 28, 2015. This eligibility list will be valid for one (1) year after the date on which the written examination was given or until the list is exhausted.   - a. An indefinite suspension for Firefighter Justin Hutto effective August 27, 2015. A Release and Settlement Agreement signed on August 27, 2015 reduced the indefinite suspension to a ninety (90) day suspension without pay.
