*** Per Section 2-203 of the Municipal Campaign Finance Regulations, a candidate for Mayor or City Council or specific-purpose political action committee registered with the City of San Antonio and formed for the purpose of supporting or opposing a candidate for Mayor or City Council shall not accept nor deposit campaign contributions after midnight on the 4th calendar day before the Regular Municipal Election Date. Contributions received after the deadline or contributions not deposited by the deadline may be deposited during the subsequent contribution cycle. Such contributions will be subject to limitations for the contribution cycle during which they are deposited.

Municipal Requirement
(Contributions Only)
June 4, 2015 thru 12 midnight on June 9, 2015 ***
(due Wednesday, June 10, 2015)

*** Per Section 2-203 of the Municipal Campaign Finance Regulations, a candidate for Mayor or City Council or specific-purpose political action committee registered with the City of San Antonio and formed for the purpose of supporting a candidate for Mayor or City Council shall not accept nor deposit campaign contributions after midnight on the 4th calendar day before the Run-off Election Date. Contributions received after the deadline or contributions not deposited by the deadline may be deposited during the subsequent contribution cycle. Such contributions will be subject to limitations for the contribution cycle during which they are deposited.
