Building Standards Board**

**SAN ANTONIO (July 6, 2016)** – The City of San Antonio is seeking applicants for four At-Large positions on the Buildings Standards Board (BSB). This board consists of two seven-member panels that hear and rule on violations of the San Antonio Property Maintenance Code (SAPMC) and summary abatement appeals.

Property owners are allowed to appeal a SAPMC Notice of Violation to the BSB based on issues of interpretation, intent, and application of code requirements. The BSB may issue civil penalties for failure to comply with the SAPMC. The panels also rule on cases related to the repair or demolition of unsafe structures. Meetings are held at the Cliff Morton Development and Business Services Center, located at 1901 S. Alamo St. Location and times of meetings are subject to change and can be verified with the liaison.
