
Before me, the undersigned authority, on this day personally appeared (name) Ezra A. Johnson, who being by me here and now duly sworn, upon oath says:

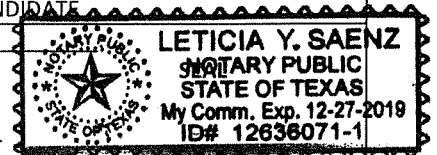
I further swear that the foregoing statements included in my application are in all things true and correct."
