In order to register your pet in the city, pets are required to be *current* on their rabies vaccination, and have a microchip ID (COSA preferred) or identification number.

Intact Dog Permit

SEC.5-107 – ADOPTED 12.13.07; EFFECTIVE 01.01.2009

- (a) Any owner or keeper of a dog that is not spayed or neutered must obtain an intact dog permit, unless the dog qualifies for a certified medical exception from a licensed veterinarian or is less than six (6) months old.
- (b) This Section shall not apply to:
 - (1) A dog or cat owner who is a nonresident of this City and is keeping the subject pet in the City for fewer than sixty (60) days; or
 - (2) Dog or cat owners who have been a resident of this City for fewer than thirty (30) days.
