ADMINISTRATIVE HISTORY:

The 37th District Court of Bexar County was originally created by the Texas legislature in 1884 to hear criminal cases for crimes committed in Bexar County. The 37th District Court shared the Bexar County Courthouse with the 45th Judicial District Court. The 37th District Court served as the county's primary criminal court until the creation of the 2nd criminal district court for Bexar County in 1955 with the creation of 175th District Court.

SCOPE AND CONTENT:

Records include criminal case files maintained by the 37th District Court of Bexar County. The case files are arranged chronologically by case number beginning in May, 1908 through October, 1916. Each case file includes papers filed in court, such as charges filed against the defendant, witness lists, subpoenas, capias, indictments, appeals, and occasionally court transcripts. The case files document the trials of various criminal defendants, including those charged with homicide, aggravated assault, swindling, theft, rape, burglary, forgery, bigamy, seduction, keeping a disorderly house, adultery, keeping a cockpit, sodomy, perjury, embezzlement, and pandering. The collection also includes an inventory of microfilmed case files for both the civil and criminal courts of Bexar County held at the record center of the District Clerk's office.
