ADMINISTRATIVE HISTORY:

The San Antonio River Corridor Advisory Committee was created in 1974 by a San Antonio City Council ordinance as “an advisory committee to the City Council for providing policy guidance and insuring the coordination of governmental, quasi-governmental and private efforts in development along the San Antonio River and Olmos Basin on the north to Mission Espada on the south.” Six public agencies are represented on the Executive Committee: the Alamo Area Council of Governments (AACOG), Bexar County, the City of San Antonio, the San Antonio Development Agency (SADA), the San Antonio Independent School District (SAISD) and the San Antonio River Authority (SARA). The Committee oversees commercial development along the river as well as neighborhood revitalization and flood abatement projects.

SCOPE AND CONTENT:

Collection consists of correspondence, reports and meetings and workshop files that document the activities of the San Antonio River Corridor Advisory Committee between 1974 and 1992. The collection was originally housed at the Texana/Genealogy Department of the Central San Antonio Public Library since 1998 through 2009, when it was transferred to the City of San Antonio Municipal Archives records facility.
