# OUR PART OF TOWN

Talent Competition



Talent Shows are held in each City Council District. Acts will be judged in three (3) categories: 12 & under, 13 –19, and 20 & over. One (1) winner from each category will be selected to represent their City Council District at the Final at a date TBA. The overall winner from each category will receive a trophy, monetary awards and prizes.

### CONTESTANTS **MUST**»»

- Reside in the Council District they are performing for.
- Compete in only **one** District show.
- For group entries, at least **one** member must reside in that Council District.

### AT THE AUDITION»»

- Wear stage attire and bring your own accompanist, background music, or props used in the act.
- Set-up time for placing props on stage is limited to thirty seconds or less.
- CD's only**, single track and no cassette tapes.
- No Lip-synching. Limit routines to no longer than 2 ½ minutes and edited for performance. Routines longer than 2 ½ minutes may be disqualified.**
- Singers may not have lead voice on CD accompaniment at Audition or Talent Show. Background vocals are permitted.
- Lyrics must be appropriate for family and TV audience.
- Not adhering to these rules will result in the routine being edited from the taped show and possible disqualification.
- District talent routines must be the same as performed at the audition.
- Age is determined by the District Talent Show date.
- Address verification is required, such as a valid Drivers License, recent utilities bill or a recent school report card.
- All judges' decisions are final.**

### AT THE DISTRICT TALENT SHOW»»

- Contestants should arrive **NO LATER THAN 6:00pm.**
- Music should be turned in by 6:45pm for proper show preparation or the contestant may be disqualified.**
- Contestants should bring the original CD and a backup CD of their music.
- District winning routine must be the same routine performed at the Finals**

**All district talent show participants will be posted on the official city website, [www.sanantonio.gov/parksandrec](http://www.sanantonio.gov/parksandrec) after all auditions are complete and scores are reviewed. The listings of selected contestants for the ten council district talent shows will be available by approximately August 5, 2009.**

**All auditions & shows are free and open to the public.**
