I have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote. I am aware of the nepotism law, Chapter 573, Government Code.

I further swear that the foregoing statements included in my application are in all things true and correct."

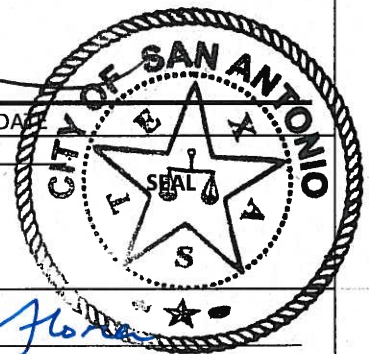

Notice to all Applicants for a Place on the Ballot:



The address listed on your Application for a Place on the Ballot must match the address listed on your Supplemental Documentation.

Supplemental Documentation to be utilized for residency verification includes:

- Valid Voter Registration Certificate
- Current Utility Bill
- Current Bank Statement
- Government Check
- Original Paycheck
- Other Current Government-Issued Document with Name and Address

Signing this Supplemental Documentation Form is an acknowledgment of having read the terms and will serve as authorization for the Office of the City Clerk to access and use provided records for the purpose of verifying residency.

In signing this form, you are acknowledging that the documents submitted are public records subject to the Texas Public Information Act. This Supplemental Documentation Form shall be published with your Application for a Place on the Ballot on the Office of the City Clerk's Election Webpage.
