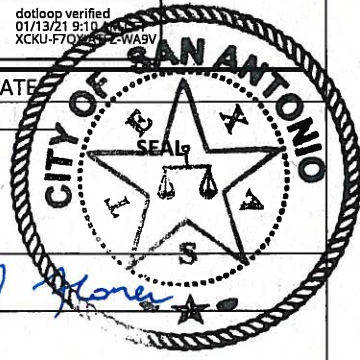

**Notice to all Applicants for a Place on the Ballot:**


In accordance with Ordinance 2017-11-30-0920, all candidates seeking office must file an Application for a Place on the Ballot and are required to submit two (2) supplemental documents for the purposes of residency verification by the Office of the City Clerk. The address listed on your Application for a Place on the Ballot must match the address listed on your Supplemental Documentation.

**Supplemental Documentation to be utilized for residency verification includes:**

- Valid Voter Registration Certificate
- Current Utility Bill
- Current Bank Statement
- Government Check
- Original Paycheck
- Other Current Government-Issued Document with Name and Address  
*vehicle registration*

Signing this Supplemental Documentation Form is an acknowledgment of having read the terms and will serve as authorization for the Office of the City Clerk to access and use provided records for the purpose of verifying residency.

In signing this form, you are acknowledging that the documents submitted are public records subject to the Texas Public Information Act. This Supplemental Documentation Form shall be published with your Application for a Place on the Ballot on the Office of the City Clerk's Election Webpage.
