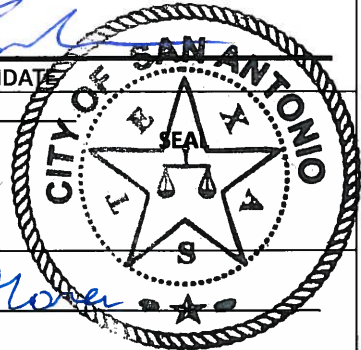

- Other Current Government-Issued Document with Name and Address
