The City Council of San Antonio convened in a Regular Council Meeting at 9:00 am. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

Present: 10 - Mayor Taylor, Bernal, Toney, Viagran, Saldaña, Gonzales, Lopez, Aguirre-Rodriguez, Nirenberg and Gallagher

Absent: 1 - Krier

Mrs. Vacek announced that Councilmember Krier was attending the Texas Municipal League Conference in Houston.

1. The Invocation was delivered by Father Francis McHugh, Pastor, St. Pius X Church, guest of Councilmember Mike Gallagher, District 10.
2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes for the Budget Work Session of August 12, 2014 and the regular Meetings of August 13 - 14, 2014.

Mr. Jack M. Finger expressed concern with the creation of four Mission Protection Overlay Zoning Districts (Item 18) noting that the United Nations would have control of the Missions in San Antonio. He spoke in opposition to the Tax Abatement being provided to CST Brands (Item 34B).

Councilmember Viagran expressed her support for the designation of the San Antonio Missions as a World Heritage Site and asked of the partners that had been involved. Shanon Miller replied that a number of partners at the Local, State and National Level had been involved in the process including Bexar County, General Land Office, and National Park Service. Councilmember Viagran thanked everyone involved and submitted a Resolution of Support to the City Clerk from the Community Relations Council of the Jewish Federation.

Mayor Taylor commended Councilmember Viagran for her leadership and stated that this was an important step for the City of San Antonio. She noted that she hoped for a favorable outcome of the designation.

Councilmember Lopez also recognized Councilmember Viagran for her leadership and expressed support for the designation. Councilmember Toney added that this would protect the Missions and looked forward to the designation.

Councilmember Nirenberg expressed support for the Resolution regarding the Overlay

District and highlighted the many investments being made throughout the city that would help celebrate San Antonio's 300th Anniversary.

Councilmember Gallagher highlighted said items due to their significance for the City of San Antonio. He stated that CST Brands was a great corporation and had raised over \$19 Million for Children's Miracle Network Hospitals. He noted that they were investing \$27 Million in property as well as creating 100 new jobs and retaining 305 existing jobs.

Councilmember Nirenberg stated that this was a big win for the City of San Antonio and highlighted CST Brands' work in the city. Councilmember Lopez expressed his support and thanked everyone involved.

Councilmember Gallagher moved to adopt the proposed ordinances for Items 34A, 34B and 34C and to approve the Resolution for Item 34D. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

A. Pre-K 4 SA Update

B. Convention Center Expansion Update

A. Deputy City Manager Peter Zaroni reported that the new school year at Pre-K 4 SA had been a great success. He stated that two new Education Centers had been built bringing the total to four Centers. He noted that there were currently 1,450 students enrolled at Pre-K 4 SA and that each Center had two Bilingual Classes. He mentioned that to gauge success in the development and implementation of the program, Pre-K 4 SA had contracted with Edvance Research and the National Institution of Early Education Research in affiliation with Rutgers University to conduct an independent evaluation. He explained that the evaluation each year would include an Alignment Study of Pre-Kindergarten Readiness Assessments used throughout Texas and an overall Program Assessment. He reported that for the first School Year, the Study measured six outcomes: 1) Cognitive; 2) Literacy; 3) Mathematics; 4) Oral Language; 5) Physical Ability; and 6) Socio-Emotional Behavior. He stated that the first year evaluation results of Pre-K 4 SA Students showed that students met or exceeded a nationally-normed sample of children their age. The Study also showed that although Pre-K 4 SA Students started the School Year significantly below the normed sample; the students surpassed in three of six outcomes and were on par for the remaining three. He noted that Pre-K 4 SA placed a strong emphasis on Family Engagement with dedicated Family Specialists working with families. He mentioned that Pre-K 4 SA partnered with the Baptist Health System's Student Program where their students earned school credit for their service by providing free screenings for Vision and Hearing to all families enrolled at Pre-K 4 SA. He highlighted the Professional Development to Pre-K 4 SA Teachers and Assistants and added that they would build upon successes in the first year by focusing on high-quality Pre-Kindergarten Services and Innovation.

Mayor Taylor and the City Council thanked staff for their work on Pre-K 4 SA.

Item 35B was not addressed.

He added that the case would require nine votes for approval due to the amount of opposition.

Councilmember Gallagher moved to continue Item Z-10 until November 6, 2014. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Councilmember Saldaña recused himself from Items P-1 and Z-1 by exiting the Council Chambers and noting that he submitted the recusal forms to the City Clerk.

John Jacks presented Item P-1 and stated that it would amend the future land use plan contained in the Midtown Neighborhood Plan. He stated that staff and the Planning Commission recommended approval.

For Item Z-1, he reported that staff and the Zoning Commission recommended approval. He stated that of 23 notices mailed; seven were returned in favor and 12 were received in opposition. He noted that the Beacon Hill Neighborhood Association was in support of the request. He added that due to the amount of opposition, the case would require nine votes for approval.

Mayor Taylor stated that she had the opportunity to discuss the case with a few individuals and appreciated the correspondence that she had received. She noted that there had been new developments over the last two days and would entertain a motion to continue the items in order to address concerns.

Councilmember Aguirre-Rodriguez moved to continue Items P-1 and Z-1 until November 6, 2014. Councilmember Toney seconded the motion. Councilmember Aguirre-Rodriguez stated that they needed additional time to understand the details and get a better idea of how to best move forward.

Councilmember Bernal stated that it was difficult to support either the neighbors or a small business but hoped they could find a way to make it work for all parties involved. He noted that the building in question had been used as a business and as a residence in the past and that the Neighborhood Plan identified it as both. He added that they would be exploring options for parking for the Art Gallery.

Mayor Taylor called upon the citizens registered to speak.

Rob Killen stated that he was speaking on behalf of the applicant in support of the request. He presented a map of the area and noted that the requested use was compatible with the area. He noted that they had submitted a request to the Zoning Board of Adjustment to address the three space parking requirement and staff was supportive of the request. He added that the Zoning and Planning Commissions, Staff, and the Beacon Hill Neighborhood Association were all supportive of the request.

Lewis A. Herbeck, Jr. addressed the City Council in opposition to the request. He stated that he lived in the neighborhood and was concerned with the parking, traffic and decrease in property values.

Chris Sauter spoke in favor of the zoning request. He stated that San Antonio lacked in Art Galleries and felt that Local Artists should be supported. He noted that there were other Artist Studios and Galleries in the area and that the parking impact would be limited.

Jess Gonzalez stated that she was representing the Esperanza Peace and Justice Center in opposition to the zoning request. She expressed concern with the encroachment by Commercial Development and that no policy existed to address Gentrification.

Carmen Tafolla stated that she had served as the City's Poet Laureate from 2012-2014 and was an Associate Professor at UTSA. She noted that she was an Artist and supported the Arts but was opposed to the zoning request. She added that she lived in the neighborhood and was concerned with the commercialization of a residential area.

Karen Herrera and Madeleine Nerio each played a video of various individuals speaking in opposition to the zoning request.

Hills Snyder stated that he was in support of the zoning request.

Jessica Fuentes stated that her parents had purchased a home in the neighborhood and that she was speaking on her mother's behalf in opposition to the zoning request. Ms. Fuentes noted that she had also purchased a home in the neighborhood and had lived in Beacon Hill for over 30 years. She expressed concern that the Art Gallery had been operating without the proper zoning and parking requirements.

Jerry Lockey spoke in support of the Art Gallery and stated that it would not change their Neighborhood Plan. He added that the Beacon Hill Neighborhood Association was in favor of the zoning request and had held several meetings to gather input from the residents.

Billy Lambert stated that he was the original applicant for the zoning request and had always resided in the Downtown Area. He provided a history of the building and noted that he had discussed their proposal with the Neighborhood Association and received support. He mentioned that he had been going through this process for 14 months and needed to work.

Celeste Wackenhut stated that she was Co-Applicant and spoke of the process they had gone through over the last 14 months. She noted that they had welcomed members of the Art Community into their home and wanted to bring Art, Design Concepts, and Education to the area. She expressed concern that they had gone bankrupt during this time and that they had been harassed by Ms. Jessica Fuentes. She asked if she had the right to allow public access to a building constructed for public use.

Reverend Peter Manfred stated that he was a Retired Lutheran Minister and had become involved in the case through Mr. Billy Lambert. He noted that he knew Mr. Lambert and Ms. Celeste Wackenhut very well and they were people of good heart and spirit. He expressed concern with the dissemination of false information.

Ann Fitzgibbons stated that she was supportive of the request and felt that the applicants wanted what was best for the neighborhood.

Cosima Colvin stated that the Beacon Hill Neighborhood Association was open to anyone that lived in the area regardless if they were homeowners or renters. She noted that the process had been open, inclusive, transparent and democratic and that the Art Gallery would benefit the community.

Cynthia Spielman stated that she had lived within walking distance of the Art Gallery for 15 years and was supportive of the zoning request. She noted that she did not feel the request was unreasonable and that it would help revitalize the area.

Sarah Sudhoff stated that the Beacon Hill Neighborhood was a friendly, diverse, and walkable neighborhood and she was supportive of the rezoning.

Alonzo Alston addressed the City Council in support of the rezoning. He stated that neighborhoods should evolve and grow and felt that the Art Gallery would benefit the neighborhood.

Jessica O. Guerrero stated that she was opposed to the rezoning due to Gentrification. She noted that although it was important to support the business community, it was also necessary to support neighborhoods.

Rolando Briseno stated that he lived across the street from the Gallery and was in support of the rezoning. He noted that the Fredericksburg Corridor was in dire need of new businesses and did not feel that parking was a significant issue.

Charlotte Nerio played a video of various individuals in opposition to the rezoning.

Mrs. Vacek announced that seven written testimonies had been received in opposition to the zoning request from the following individuals: Edward Sanchez, Laura Rodriguez, Andrea Porter, Joan Lorenzi, Juan De Leon, Adrian Guerrero, and Gloria Garza.

Mayor Taylor thanked everyone that spoke. She stated that Mayor Castro had created the Mayor's Task Force on Preserving Diverse and Dynamic Neighborhoods and they would

be working on a series of policy recommendations.

Councilmember Aguirre-Rodriguez stated that she was a Small Business Owner and understood the concerns that had been addressed. She spoke of the need for trust on both sides of the issue and added that parking was a long-term issue that needed to be addressed.

Councilmember Nirenberg stated that the Art Gallery would add richness and cultural vitality to the neighborhood but understood the concerns regarding parking. He added that he hoped that they could come to a resolution.

Councilmember Gonzales stated that she was a Small Business Owner and had been through a lengthy zoning case that cost a great amount of money. She spoke of parking issues that were prevalent within the Inner City.
