Applicants being accepted for the Building Standards Board

SAN ANTONIO (December 14, 2015) – The City of San Antonio is seeking applicants to serve on the Buildings Standards Board (BSB). This board consists of two seven-member panels that hear and rule on violations of the San Antonio Property Maintenance Code (SAPMC) and summary abatement appeals.

The following positions are currently vacant:

- Architect
- Architect (with experience in addressing adaptive reuse of historic buildings)
- Engineer (with experience in addressing adaptive reuse of historic buildings)
- General Contractor
- General Contractor ((with experience in addressing adaptive reuse of historic buildings)
- Social Worker
- Health Care Professional (two positions)

A professional property manager may be substituted for one general contractor and/or one social worker. Applications are available at:

Property owners are allowed to appeal a SAPMC Notice of Violation to the BSB based on issues of interpretation, intent, and application of code requirements. The BSB may issue civil penalties for failure to comply with the SAPMC. The panels also rule on cases related to the repair or demolition of unsafe structures. Each panel holds a hearing twice per month unless otherwise indicated. Meeting dates are the first and third Thursdays for Panel A, and the second and fourth Thursdays for Panel B, and generally run from 9:00 a.m. to 2:00 p.m. Meetings are held at the Cliff Morton Development and Business Services Center, located at 1901 S. Alamo St. Location and times of meetings are subject to change and can be verified with the liaison.
