



During the 2005 regular session the Texas Legislature passed House Bill 914 relating to the disclosure of information concerning local government officers and vendors. The bill has been codified as Chapter 176 of the ***Texas Local Government Code***. The law requires vendors, like Linebarger Goggan Blair & Sampson, LLP, to file a conflict of interest questionnaire authorized by the State and identified as "Form CIQ".
