ADMINISTRATIVE HISTORY: Urban renewal promotes efforts that eliminate urban blight and slums through legal activities such as slum clearance, redevelopment, rehabilitation and conservation.

The Urban Renewal Agency, originally referred to as the San Antonio Development Agency (SADA), was established by voter referendum in 1957. SADA was organized to develop and implement strategies to eliminate community slum and blight and also meet the revitalization and redevelopment directives of the City of San Antonio as identified by City management and as approved by the City Council.

SCOPE AND CONTENT: This collection consists of Ordinances, Resolutions, and Maps adopted by the City of San Antonio City Council.

Ordinance numbering systems:

Prior to 1979, Ordinances and Resolutions were not assigned unique identifying numbers. Prior to 2006, the unnumbered ordinances are referenced by their location in a City Council Minutes or Ordinance Book, and each ordinance or

resolution may be present in one or both books. In the case of Ordinance OH-135, OH indicates its presence in Ordinance Book H, on page 135 of that book.

Ordinances were assigned additional numbers. Ordinance MK-577 indicates that the Ordinance is cited in Minute Book K, on page 577 of that book. In addition to this numbering system, Ordinances are also found with a single number reference, which follows a sequential numbering pattern for Ordinances as they are passed. An example of this is Ordinance 330.

From November 30, 2006 onward, Ordinance numbers are referenced by year-month-day-agenda item. An example is Ordinance 2006-11-30-1369, which was adopted on November 30, 2006.

Resolution numbering systems:

Prior to May 21, 1970, Resolutions were not numbered. Unnumbered resolutions have been assigned a unique, identifying number during processing that follows the YYYY.MM.DD format. An example of this is Resolution 1935.09.05.

Resolutions have also been referenced by their presence in a Minute Book, such as Resolution MN-5.1.

After May 21, 1970, the city Resolution numbers were identified using the agenda item number, for example, Resolution 70-29-38.

NOTE: The captions in the original Ordinances and Resolutions are capitalized, and have been used in the finding aid description exactly as they appear in these documents.
