Provisional Ballots



The results noted within this report do not include tabulation of 908 County-wide provisional ballots that are still outstanding. None of the municipal election results will be affected by the tabulation of these provisional ballots as none had margins smaller than 5,451 votes. Once provisional ballots have been tabulated a final ordinance will be submitted and complete results will be updated.
