

**Addendum to Stay Home Work Safe Measures**

Consistent with the Texas Governor's Executive Order GA-14 dated March 31, 2020 and the Mayor's Emergency Order #5 ("Fifth Declaration"), this Addendum to Stay Home Work Safe Measures sets out additional measures by Ron Nirenberg, Mayor of the City of San Antonio.

- a. **Long-term Care Facilities.** The Centers for Disease Control and Prevention (CDC) has identified that staff members working in multiple long-term care facilities can contribute to intra- and interfacility spread of COVID-19. Based on this guidance, I hereby order any individual that provides in-person services, or is otherwise employed or staffs a long-term care facility (e.g. nursing home, or assisted living facility), and has direct patient contact shall be prohibited from working in, or visiting, more than (1) long-term care facility for any purpose as a result of the increased risk for transmission of COVID-19 to an at-risk population. The prohibition shall extend to any agency or organization who employs individuals for purposes of staffing or on a temporary basis. Notwithstanding, this prohibition does not, and is not intended to, impact or restrict the ability of an individual, organization or entity to operate as an exempted business under the Order/Declaration of either the Texas Governor or the County Judge for Bexar County, but shall only restrict the ingress/egress and movement of persons into or out of more than one nursing home facility. Additionally, long-term care facilities should follow all additional CDC guidance to take proactive steps to protect the health of residents and preserve the health care workforce by identifying and excluding potentially infected staff members, restricting visitation consistent with the Governor's Executive Order, the Mayor's Fifth Declaration and the County Judge's Executive Order, ensuring early recognition of potentially infected patients, and implementing appropriate infection control measures.
  
- b. **Enforcement.** In addition to enforcement through citation and fine, the City will exercise its authority to further enforce compliance with the Mayor's Fifth Declaration for repeat violations by businesses by pulling the Certificate of Occupancy for those violating businesses.
  - 1) **All Food, Household Staples Retail, including those doing pick-up/delivery.** All food, household staples retail establishments, including those doing pick-up/delivery shall:
    - a. Limit the amount of people at pickup or in an establishment so that social distancing may be maintained;
    - b. Implement an organized line system where people are spaced at least 6 feet apart; and

- c. Post in a highly visible location, the establishment's guidelines that meet (a) and (b) above.
- c. **Community Parks and Property**. All recreational areas where social distancing and sanitizing requirements are difficult or impossible to meet, including community and school playgrounds, outdoor exercise equipment, tennis courts, skate plazas, splash pads and basketball courts including those located in apartment complexes or HOA areas, shall close for the duration of the Fifth Declaration.
- d. **Municipal Parks and Property**. The City Manager directs that certain facilities within municipal parks be closed to further reduce the spread of COVID-19. Use of our parks must continue to be consistent with guidance from the Centers for Disease Control and Prevention regarding social distancing.
- 1) Beginning at 11:59 PM on Tuesday, March 31, 2020, City community centers, clubhouses, adult and senior centers (except for meal pick up), park basketball courts, outdoor exercise equipment, playgrounds, tennis courts, skate plazas, splash pads and the Reservation Counter at Ron Darner Park Headquarters will be closed to the public. These closures will remain in effect until the earlier of the following: the City Manager determines that the closures are no longer necessary; or, the Mayor's Declaration of Public Health Emergency and the Governor's Executive Order GA-14 are rescinded, or expire.
  - 2) Beginning at 11:59 PM on Friday, April 10, 2020, all persons must vacate City parks and all City parks will close to the public until 5:00 AM on Monday, April 13, 2020. The park trails, linear parks, and greenways, for example the Howard W. Peak Greenway Trail System, will remain open for walking, running, or biking as long as users consistently follow social distancing.
  - 3) Beginning at 11:59 PM on Friday, April 3, 2020, all municipal and private golf courses, and driving ranges, will be closed for golf or frisbee play until further notice.
